Office Manager's Report – Judy B.

•Membership List (as of the 5th of the month) 70, up 3 from last month.

•Utilization Report: 6,340, up 602 from November. Avg. per day 205. Last December: 6,045, December 2012: 5,484.

•Year-to-date utilization is 67,967 vs. 65,718 last year.

Finances:

Profit and Loss: The Profit & Loss for November and December and 2015 Budget were review at the Finance Meeting.

•The P&L Report and 2015 Budget were accepted by the Board.

oNet Income December: \$30,301.89.

oBudget for December: \$11,034.07.

oEnd of month Checking Balance" \$40,796.37.

◦End of month budget balance was \$13,771.53.

• Final \$\$ spent on garden shed \$5,785.50 including new water heater and new tables.

•For 2014 we deposited \$33,600 against our mortgage principal. That reduced our interest payment by approx. \$100 per month. Now we are adding \$100 more toward the principal every month.

•Our current mortgage balance is \$188,474.39. We started 2014 at \$235,277.66. Total pay down on mortgage principle, \$46,803.27.

•We added \$5,000 to our Prudent Reserve for 2014 bringing the total to approximately \$20,000.

•Our fundraising total for 2014 was \$27,108.26.

◦Counter/floor project will begin in May. We have a Donor offering \$10,000 toward this project. In terms on budgeting, that will bring us to \$25,000 to build a new counter and flooring for the entry way and hall.
