Steve I. asked Lynn to show him what she was referring to and Lynn said yes. She also brought up that the water heater shed is falling down. Mark said that it would be fixed.

Office Manager's Report – Judy B.

- Membership List 76, same as last month
- Utilization Report: 6,045, up 29 from last month. Avg. per day 195. Last December: 5,484, December 2012: 5,830, 2013: 65,716, 2012: 62,972.
- Profit and Loss: Net income for December: \$14,382.74
- End of Month Operating Account Balances: \$28,210.94
- 2014 Budget was presented for review as amended. Judy B. answered questions and then made a motion that the Budget be approved. Steve I. seconded the motion and it was approved.
- The Silent Auction is closed out. All of the items have been picked up and all of the monies have been collected. With Steve's help, thank you 501(c)3 letters have been sent to all of the donors as well.
- Currently writing the submittal for the Sheriff's grant which is due February 7th.
- Must figure out how to marry our Credit Card function with AccuPOS and Iberia.
- United Way grant submittals are due March 1st.

House Maintenance Report - Mike L.

• The roof drains have been calked but it's not just that area leaking. Some leaks are from when the tree fell onto the roof which is a separate issue.

- Dan R. gave an update on the email follow-up 59 people have signed up for the newsletter. Governance Dan R.
 - Steve I. said that he had gotten the higher level donor list to Dan. Dan said that he would divide it up after the next Board Meeting.
 - We need to change the bylaws. Currently it takes 20% of the membership to make bylaw changes. Very difficult to get 20% to attend a meeting. Thinking we should change it to unanimous approval by the Board or 20% of the membership. Lynn A. said that unanimous Board approval takes all the power from the members. She suggested that the Board throw a party and serve pizza to get members to attend. Dan said that it would be a distraction. Steve I. said that at this time it was a proposal to be discussed and would be voted on by the Board and then taken to the membership for a vote.
