ARTICLES OF INCORPORATION
OF
ANCHORS AWEIGH CLUB, INC.

The undersigned subscribers of these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is Anchors Aweigh Club, Inc.

ARTICLE II

The purpose for which this corporation is organized is for the education and rehabilitation of alcoholics and other persons interested in the disease of alcoholism in a private club setting.

ARTICLE III

This corporation is to exist perpetually.

ARTICLE IV

Any person of good character, believing he or she has an alcoholic problem, may become a member upon agreeing to pay an assessment, fixed by the Board of Directors, monthly in advance, to help defray the operating expenses of said corporation, having first obtained thirty (30) days sobriety. Members agree to abide by all rules and regulations affecting the operations of the corporation. Any member in good standing shall have the right

to vote on all pending questions, including the election of Directors. The Board of Directors has the right to refuse any application, or cancel any membership, for cause. Any person so affected may appeal to the Board of Directors, in writing, for a personal hearing which shall be granted. Any person, sympathetic to the principles for which this corporation is formed, may become an associate member upon payment of the monthly assessments and have full privileges, except the privilege to vote at meetings of the corporation.

ARTICLE V

The initial post office address of the principal office of this corporation in the State of Florida is: 404 Virginia Street, Key West, Florida 33040. The Board of Directors may, from time to time, move the principal office to any other address in the State of Florida.

ARTICLE VI

This corporation shall have nine (9) directors, initially. The number of Directors may be increased or diminished from time to time by By-Laws adopted by the members.

ARTICLE VII

Each and every By-Law and/or Amendment of these Articles of Incorporation may be made, altered, rescinded, proposed or adopted by the Board of Directors, proposed by them to the members, and adopted at a membership meeting providing said By-Law and/or Amendment has been posted on the Club bulletin board at least seven (7) days in advance and that a quorum of twenty five percent (25%) of the membership is present.
