House report-Mike L.:

- Update on ramp: needed to purchase more materials then planned, but Mike did not charge for his time. This was accepted through Steering committee e mail vote and has been paid. Mike will stain wood and it will need to be cleaned on a regular basis to keep dirt and mold under control. Members agreed the ramp looks beautiful;
- The chairs in the garden need repair. Mike has not found the extra slots that were purchased earlier. Chris knows where they were ordered from and will follow up. Mike recommended if we purchase new chairs we get stackables;

Treasurer's Report –Tom G.:

- Bank statement shows \$33,336.49 in prudent reserves and \$13,085.68 operating account; Bal of mortgage from the bank statement \$25,623.15. First State Bank: \$22,195.79 Misc. and \$30,335.17 Building Reserves.
- The Finance Committee will look at options for reserves that may be more financially beneficial;
- One of the insurance payments has still not been resolved. The Insurance Company shows it paid but it has not cleared the bank. Tom S. and Nancy agreed to research it with the insurance company so that we can get our full reimbursement from the Sheriff's department. Nancy agreed to follow up and advise;
- It appears the Auction has brought in \$13,888 net revenue;

- Tom S. shared the Monthly and Quarterly Operating Dashboard through the end of October 2018;
- Tom S. recommended that the Finance Committee look at cash picture and determine when to pay off the mortgage.

- The Anonymous Angel event was very successful net income of \$13,888. 100% of these
 proceeds should go to the Burn the Mortgage as planned by the committee. Next year
 this event will have its own dedicated bank account, still being a part of Anchors
 Away;
